 - (d) If there are more than three nominations to fill the vacancies, a vote will be required, and copies of all nominations will be posted on the Club notice board.
 - (e) Voting can only be done by attending on the night in accordance with the Club Rules. No proxy votes for the AGM.
 - (f) Voting will open at 6:00 p.m. and close at 7:30 p.m. on Wednesday 1st of October 2024.
