

APPLICATION FOR APYAC "ASSOCIATE MEMBERSHIP"

Albert Park Yachting & Angling Club (APYAC) Rules (Clause 5.4) provide for the **SPOUSE** or **LIFE PARTNER** in a domestic relationship) of a current **Full Member** of APYAC to be nominated to join APYAC as an **Associate Member**.

For these Rules, a **Life Partner** means a person with whom the current financial Full Member shares a genuine, ongoing domestic relationship akin to marriage, irrespective of gender or legal marital status.

The Life Partner may be nominated for Membership by a current financial Full Member, subject to the following conditions:

- a) The Member and the nominee have been in a domestic partnership for a minimum of twelve (12) consecutive months before the date of nomination.
- b) The Member declares that the relationship is genuine, exclusive, and ongoing.
- c) The Committee may, at its discretion, request reasonable evidence of the relationship, including but not limited to:
 - i. A statutory declaration by the nominating Member or both parties;
 - ii. Joint documentation such as a lease, utility bill, or property ownership.
- d) A Member may nominate only one Life Partner at any given time.

If the domestic relationship between the nominating Member and the Life Partner changes or the nominating member's membership ceases, the Associate Membership will lapse. The nominating (current) member <u>must</u> inform APYAC within 14 days should the relationship cease.

The Committee shall have full and final discretion to accept or decline any nomination made under this Rule. Any decision made by the Committee in relation to a Life Partner nomination shall be final and not subject to appeal.

Associate Members enjoy social rights and access to APYAC Clubhouse facilities, but do not have boathouse or launching rights, and are not entitled to vote at Club meetings or elections.

The Associate Membership category is not charged an annual fee; however, upon approval of this application by the Club's Membership Committee, a charge of \$25 will be invoiced to cover the cost of administration and membership card.

By signing and submitting this application, both parties acknowledge that they understand the above and confirm the details below. The Associate Member (Applicant) also confirms that they:

- wish to become a member of the Association.
- support the purposes of the Association; and
- agree to comply with these Rules.

Important information:

Membership Cards will be issued and may be used for:

- Front door access to ease sign in procedures (tap on only).
- Club attendance record as an "Associate Member."
- Bar & Snack purchases when & if funds are loaded.

The application will require input and acknowledgement from both the current member (nominee) and the applicant for Associate Membership.

The nominee's APYAC membership number will be needed for the application and both the member and applicant are required to sign before submitting.

On approval,

- 1. An invoice will be sent to the applicant for \$25
- 2. Member cards will be printed in house following payment of the invoice.
- 3. Please allow 10 14 business days to complete the printing process.
- 4. Notification will be sent by email to the applicant when cards are available to collect from the office.
